

DOMTEK BUILDING PRODUCT'S POLICY OF QUALITY AND DURABILITY IN THE MANUFACTURE OF ITS PAINTED ROOFING AND SIDING PRODUCTS, ARE REPRESENTED BY THIS LIMITED WARRANTY, UNLESS OTHERWISE NOTED. THIS WARRANTY IS VALID FOR A PERIOD OF FORTY (40) YEARS FROM THE DATE OF SHIPMENT.

WARRANTY COVERAGE

1. During the terms of this 40-year Limited Warranty, the painted panel will not perforate or fail structurally due to deterioration from red rust.
2. The paint will not:
 - A) Crack, check or peel (lose adhesion) for forty (40) years. This does not include micro-fracturing, which may occur in proper fabrication of the building parts.
 - B) Chalk in excess of a numerical rating of 8 when measured with the standard procedure specified in D4214-98, Method D659 on sidewalls for a period of thirty (30) years.
 - C) Chalk in excess of a numerical rating of 7 when measured with the standard procedure specified in D4214-98, Method D659, on roofs for a period of thirty (30) years.
 - D) Fade or change colour by more than 5 units of color for sidewall panels in accordance with the standard procedure of D-2244-02, for a period of thirty (30) years.
 - E) Fade or change colors by more than 6 units of colour for roof panels in accordance with the standard procedure of D-2244-02, for a period of thirty (30) years.
3. On non-vertical installations, the Products will not exhibit accumulation of red rust caused by acid rain on coated surfaces, for a period of ten (10) years on G-90, fifteen (15) years on G-60 HDG steel beyond 1/2 inch from edge of panel.

LIMITATIONS ON WARRANTY

1. This warranty is extended to the original buyer only and is not transferable or assignable.
2. Damage to the panels caused directly or indirectly by panel contact with fasteners is not covered by this warranty. The responsibility for selection of suitable long-lasting fasteners rest solely with the Buyer.
3. Steel shavings or minute particles from sawing sparks that come into contact with the pre-painted finish is not covered by this warranty.
4. Minor color variances between separate orders are not covered by warranty.
5. Abnormal atmospheric conditions to which this Warranty does not apply include, but are not limited to hail, exposure to corrosive or harmful chemicals (whether solids, liquids or gases), airborne contaminants, animal wastes, exposure to salt water spray, decaying materials, wet absorptive material, and internal contamination created by improper ventilation or improper housekeeping. The warranty does not cover damage caused by acts of God, falling objects, external forces, explosions, fire, riots, civil commotion, act of war excessive radiations or other such similar or dissimilar occurrences beyond our control.
6. Defects or damage to the pre-painted finish of the steel roofing and side panels, after delivery by Domtek Building Products, resulting from handling, shipping, transit, processing, improper storage or installation, or prolonged moisture contact or contact with corrosives and/or similar materials are not covered by this warranty.

BUYER'S OBLIGATION

1. The Buyer shall inspect material when received from Domtek Building Products prior to installation so as to mitigate expenses involved in repairing, replacing or repainting defective sheets. The Buyer accepts responsibility upon receipt of the material in the conditions described in Paragraph 6 of Limitations on Warranty.
2. Any claim on account of a defect in the products or for any other cause whatsoever shall be deemed waived by Buyer unless written notice thereof is given to the Seller within thirty (30) days after discovery of the defect and within the applicable warranty period. Buyer must submit proof of purchase in the event of such claim. Seller shall be given reasonable opportunity to investigate all claims.
3. To be effective, the buyer shall include in all claims under this warranty adequate identification of materials involved in the claim, including original invoice.

EXCLUSIVE REMEDY

1. If it is determined by Domtek Building Products, upon inspection, that a claim for defective steel roofing and siding panels is valid, liability for breach of this Warranty and the sole remedy of the buyer shall be limited exclusively to the cost of either repairing, or replacing, nonconforming panels or sheets.
2. DOMTEK BUILDING PRODUCTS, ITS OFFICERS, DIRECTORS, SERVANTS AND AGENTS SHALL NOT BE LIABLE FOR ANY LOSSES, DAMAGE, EXPENSES WHETHER DIRECT, INDIRECT, OR CONSEQUENTIAL, CAUSED BY, OR RESULTING FROM, THE USE OF DEFECTIVE OR NON-CONFORMING STEEL PANELS AND SHEETS OR FOR ANY OTHER INCIDENTAL OR INCONSEQUENTIAL DAMAGES, AND THE TOTAL LIABILITY FOR DOMTEK BUILDING PRODUCTS, ITS OFFICERS, DIRECTORS, SERVANTS AND AGENTS IS EXPRESSLY LIMITED TO THE PURCHASE PRICE OF THE STEEL PANELS OR SHEETS. Without limiting the generality of the foregoing, the Warranty pertains to product only, and the seller shall not be liable for damages for or relating to labour or loss of use of structure or damage to contents of structure.



FORTY (40) YEAR WARRANTY PREPAINTED COLOURS

THE EXPRESS WARRANTIES AND REMEDIES STATED HEREIN ARE THE EXCLUSIVE WARRANTIES AND REMEDIES APPLICABLE TO THE PRODUCTS. ALL IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE EXPRESSLY EXCLUDED.

Agreed Procedure for Determining Conformation with Specification

For the purpose of determining whether an exposed panel meets the standards set forth above, all chalk, dirt and other film deposits on the area of the panel to be tested for colour must be removed by washing prior to evaluation.

To wash the test area, use a pad of 28/24 mesh cheesecloth and distilled water and a mild detergent cleaner. Wet the cheesecloth thoroughly with the cleaning solution and rub it, using moderate hand pressure, over an area of the panel approximately 4" x 4". Care must be taken to avoid any scratching, burnishing or other physical alteration of the coated surfaces.

After washing, as described above, flush off the test area with distilled water and allow to dry.

Failure to keep condensation or moisture from nested materials may result in damage or wet storage stain, voiding manufacturer's guarantee.
